- (iv) That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.
- (v) That the school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and directions/Instructions/Guidelines issued by the Direction of Education from time to time.
- (vi) That the school shall comply with the orders/guideline of DoE and judicial pronouncements w.r.t utilization/maintenance of the school funds.
- (vii) That the school shall submit renewed the FDR within 01 month in favour of DDE(North) & Manager of the school.
- (viii) That the school shall submit the fresh Water Test Report issued from Delhi Jal Board within 02 Months to the District Authority.

- (ix) That the school shall submit the fresh Health Certificate issued from MCD within 01 Months to the District Authority.
- (x) School shall appoint special educators as per DoE order dated 21/06/2023 within 03 month and submit the documents to the District Authority.
- (xi) That the school shall comply with the order dated 20/06/2023 issued by DoE regarding submission of renewed various certificates to the Zonal Authorities of DoE.
- (xii) That the school shall comply with the order/guideline of DoE dated 07/11/2017 and judicial pronouncements w.r.t. the safety of the students and shall take all necessary steps to this effect.
- (xiii) That the school shall comply with the section 17(3) of DSEAR, 1973.
- (xiv) That the DDE District shall ensure that the aforesaid terms & Conditions are being complied with by the school Management in letter and spirit.
